MSA FINDINGS

Requirement R3 of EOP-005-AB-3 states, in part:

Each operator of a transmission facility must within sixty (60) days, or another time period agreed to by the ISO, after receiving a copy of the ISO's restoration plan updated in accordance with requirement R3 of EOP-006-AB-3 or any subsequent version of that reliability standard:

- (a) review its restoration plan;
- (b) align its restoration plan, as necessary, with the ISO's restoration plan; and
- (c) submit its plan to the ISO for approval.

ATCO Electric Ltd. contravened R3 of EOP-005-AB-3 from October 18, 2024, to December 13, 2024, as its restauration plan was not updated and submitted for approval within 60 days.

The MSA is satisfied that the conduct was a contravention of Reliability Standard EOP-005-AB-3, requirement R3. The MSA determined the severity level as Moderate in consideration of the duration of the contravention.

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an Alberta Reliability Standard. Specified penalties are set out in AUC Rule 027.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5.1 of AUC Rule 027 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance.
