## **MSA FINDINGS**

Requirement R1 of PER-005-AB-2 states, in part:

R1 The ISO and each operator of a transmission facility must use a systematic approach to develop and implement a training program for its real time operating personnel, as follows:

[...]

R1.3 The ISO and each operator of a transmission facility must deliver training to its real time operating personnel according to its training program.

The MSA is satisfied that City of Medicine Hat contravened R1.3 of PER-005-AB-2 from July 2, 2024 to March 19, 2025 as training was not delivered to all real time operating personnel according its training program.

The MSA determined this contravention to be a High severity level due to the duration of the contravention.

## NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an Alberta Reliability Standard.
