MSA FINDINGS							

EOP-008-AB-1 states, in part:

R5 The ISO and each operator of a transmission facility must annually review and approve its operating plan for backup functionality.

R5.1 An update and approval of the operating plan for backup functionality must take place within sixty (60) days of identifying any necessary changes to any part of the operating plan described in requirement R1.

[...]

R7 The ISO and each operator of a transmission facility must conduct and document results of an annual test of its operating plan that demonstrates:

- R7.1 The transition time between the decision to transfer functionality to the backup control centre following the simulated loss of primary control centre functionality and the time to fully implement the backup functionality; and
- R7.2 The backup functionality for a minimum of two (2) continuous hours.

City of Medicine Hat contravened requirement R5 of EOP-008-AB-1 from March 27, 2025, to May 1, 2025, as it did not annually review and approve its operating plan for backup functionality.

City of Medicine Hat contravened requirement R7 of EOP-008-AB-1 from March 27, 2025, to April 20, 2025, as it did not conduct and document results of an annual test of its operating plan that demonstrates R7.1 and R7.2.

The MSA is satisfied that the conduct was a contravention of Reliability Standard EOP-008-AB-1 Requirements 5 and 7. The MSA determined the contravention was lower severity.

In accordance with s. 5.1 of AUC Rule 027 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
